Road use charge - motorways and assimilated roads

In the Czech Republic, the use of trunk roads and motorways by vehicles with at least four wheels or vehicles with trailers is subject to a user charge. The toll collection technology is **changing from 1 December 2019**:

New registration for the new toll system is necessary

The electronic device of the original provider is not compatible with the new "satellite" electronic toll system. It is therefore necessary to replace it with a new one:

Toll roads, the use of which is subject to toll payment (toll roads), are from 01. 01. 2019 defined by Decree No. 243/2019 Coll. on the Use of Roads subject to Toll Payment

Starting 01. 01. 2020 will be extended the toll to motorways:

Rates for motorways and assimilated roads

Toll rates for the use of 1 km of a toll road are set by Czech Government Decree No. 240/2014 Coll. The rate varies according to the number of axles and the vehicle emission class.

The toll for the use of a particular section is given by the multiple of the rate and the length of the section.

Tolls are not subject to VAT.

The claim to Euro 6 has to be proven by a document of the vehicle (vehicle registration certificate). The EU/EHS standards complying with the emission class Euro VI or EEV have to be clearly stated in the document.

Return of an old electronic device

- Till 31. 01. 2020 the electronic device (on-board unit) can be returned in person at [25 distribution or 15 contact points](#) (origin provider).
- From 01. 12. 2019 the electronic device can be sent by post to address: **MYTO CZ, P. O. Box 33, 130 11 Praha 3, Czech Republic**: delivery not later than 31. 05. 2020; bank guarantee delivery not later than 29. 02. 2020.

Pre Pay Onboard Unit: to return onboard unit. You will need to present a registration certificate or identity card. If the operator of the vehicle is a company stated on the device, you will need to present a Commercial register statement and power of attorney if the device is returned by someone who is not stated on the statement and is not representative of the company.

Post Pay Onboard Unit: to return your onboard unit you need to present your identity card.

Power of attorney will be required (not older than three months) if the device is returned by someone who is not stated as contact person in the contract.
